PARTICIPANT HEREBY ASSUMES ALL RISKS ARISING FROM OR RELATED TO PARTICIPATION IN ANY/ALL ACTIVITIES provided by, performed at or associated with PlayArts, Inc. or Burkey Holdings, LLC, and their directors, officers, employees, volunteers, representatives, and agents, and the activity holders, sponsors, and volunteers; owners, officers, directors, employees, instructors, members, volunteers, agents, service providers, assigns, legal representatives and successors, and all business associates and partners and their respective owners, officers and employees arising from or related to PlayArts or related activities ("Owner Parties").
